2011 Smirkus Camp – Fees, Conditions and Policies

Please read all of the enrollment fees, conditions and policies before signing the registration form.

FEES AND DISCOUNTS:

1. **TUITION:** Tuition includes the cost of meals, lodging, circus training, equipment, transportation to any special outings, as well as a camp t-shirt, water bottle, group photo and an amazing circus camp experience!
2. **LAYOVER FEE:** Campers attending two consecutive sessions who stay at camp during the layover period pay a \$75.00 per night layover fee to cover the cost of meals, lodging, entertainment and supervision.
3. **CIT:** There is a room and board fee applied to those accepted into the Counselor-In-Training program. Please refer to the CIT application available on our website for costs and further details.
4. **FINANCIAL AID:** A limited number of partial scholarships are available. Eligibility is based on the applicant's income and circumstances. Applications are available for download on our website or by mail if requested. Completed scholarship applications are due by March 4, 2011.
5. **FAMILY DISCOUNT:** Families with two or more siblings attending any 2011 camp session (or with a sibling participating in the Smirkus Big Top Tour) may deduct \$50.00 per child from the total balance of their camp fees. This discount is not applied to the registration fee.

CONDITIONS OF REGISTRATION:

1. **REGISTRATION FEE:** A non-refundable \$150 fee (\$75 for Smirkling Camp) is required with the registration form for each camper and for each session enrolled. Scholarship applicants may send \$75.00.
2. **ENROLLMENT:** A completed registration form and paid registration fee will hold a space in the session requested as to the policies listed below. **AFTER APRIL 1, 2011, tuition payment in full is required with your registration in order to guarantee your space.** The required camper forms will be mailed to you by the end of March. They will also be available for download on the camp website after April 1, 2011.

POLICIES:

1. **ENROLLMENT:** Campers are enrolled on a first come, first serve basis as per the date of receipt of the registration form and fee, with the exception of those applying to Session V. Confirmation of enrollment, including an invoice, will be sent via mail or by email (if an address is supplied).

Tuition balance is due in full by April 1, 2011. Camper forms are due by May 31, 2011. Payment in full is required with registration forms received after April 1. Payment plans can be arranged through the camp office (call 802-533-7443 x21) and must be paid in full before the start date of the camper's session. All required camper forms will be mailed after receipt of final payments and will be available after April 1 on the camp website at www.smirkus.org. Camper spaces are held pending receipt of the tuition balance and camper forms. Failure to complete all forms and pay tuition by the due dates may cause a forfeiture of your child's space.

Session IV enrollment requires campers to have attended at least 2 weeks of Smirkus Camp or the equivalent circus training prior to June 1, 2011. Equivalent circus training can include involvement in a juggling/unicycle club, gymnastics team or other circus program. Please call the camp office with any questions prior to registering.

Session V requires a completed registration form and fee to hold a space in the session pending receipt and acceptance of audition materials (due by January 31, 2011). Campers should register for the session option in which they are most interested (Ensemble Work, Individual Acts or Road Show). If accepted, campers will be placed in one of the three session options based on interest and skill. Those not accepted into a Session V program have the option to attend another available Smirkus Camp session or to have their registration fee refunded less a \$50 processing fee. For more details, please refer to the Session V application available for download on our website or by mail upon request.

2. **WAITING LIST:** When a camp session fills, a wait list is started. Applicants will be notified of their wait list status. If openings occur, applicants will be contacted in the order in which registration forms were received. Registration fees are not processed until applicants are placed in a session.
3. **CANCELLATION:** Registration fees are non-refundable. If a cancellation occurs prior to April 1, 2011, any additional tuition already paid will be refunded. 75% of the tuition will be refunded for cancellations occurring between April 1 and May 1, 2011. 50% of the tuition will be refunded for cancellations occurring between May 1 and June 1, 2011. Tuition is non-refundable after June 1, 2011.
4. **REFUNDS:** There are no refunds for campers dismissed from the program due to illness or disciplinary reasons, or for campers who choose to withdraw early from the program already in session. If a camper must leave due to an injury incurred at camp, a prorated portion of the tuition will be refunded.
